IMPORTANT NOTICE FOR APPLICANTS

1. It may be noted that **this selection list is only PROVISIONAL** and is subject to the timely submission and due verification of all the applicable and mandatory documents / copies of testimonials such as matriculation mark sheet, intermediate mark sheet, graduation mark sheet, CAT / XAT / MAT / CMAT / ATMA score sheet, caste certificate, income certificate, residential certificate, BPL certificate, experience certificate, character certificate, college leaving certificate, migration certificate, employer's no-objection certificate etc. by the short listed candidates before the fixed due date to the Institute.
2. All the short listed candidates are advised to bring their original documents for verification at the time of admission positively. No admission will be confirmed unless all the original documents are presented for verification at the time of admission.
3. The appearing students at bachelors level must produce original mark sheet of graduation with minimum 50% marks in aggregate, at the time of admission latest by 31st August, 2017 or publication of the result of graduation by the Universities, whichever is earlier.
4. Rules and Regulations 2017 provided along with the MBA Information Brochure shall be applicable on all applicants.
5. The signature of the candidate on the Application Form, the Checklist, the Rules and Regulations 2017, the Provisional Admit Card and on all the other documents and places should be identical. Signature in different styles or languages at the time of application, interview and document verification may result in cancellation of candidature.
6. The Institute may withdraw or amend its offer of admission, or terminate the registration of a student, if it is found that either a false or a misleading statement has been made, or that significant information has either been omitted or withheld in his / her application form. Any material suppression of facts or submission of forged certificate by a candidate for securing eligibility and / or obtaining privileges shall lead to rejection of his/her candidature. Further, legal action can be initiated, if warranted.
7. In all matters related to admission to the MBA course of session 2017-19, the decision of the Institute shall be final and binding on the applicants.
8. Disputes, if any, are subject to exclusive jurisdiction of competent courts in Ranchi district only.
